Purpose: To provide recognition to the construction project(s) in the State of Alabama that demonstrate excellence in implementing principles associated with The Alabama Handbook for Erosion Control, Sediment Control, and Stormwater Management on Construction Sites and Urban Areas.

Criteria:

- The nomination must be postmarked by the last day of May for the year of the award.
- The construction project must be completed and NPDES permit terminated at the time of the nomination.
- The project must have been in good standing with the local unit of government (i.e. no Stop Work Orders or fines)
- The project must be at least 2 acres in size.

Selection:

Nominations will be reviewed by a core group selected from the Erosion and Sediment Control Partnership.

Consideration will be given for a Small Site Award (2 – 5 acres) and a Large Site Award (> 5 acres).

The core group will make recommendations to the Erosion and Sediment Control Partnership for award approval. The Erosion and Sediment Control Partnership will vote on the award(s) and the vote must be unanimous for approval.

Awards Recognition:

The recipient will receive an award suitable for display. The Nominee and the recipient will be recognized at the annual Clear Water Alabama Seminar. Additionally, the recipient will be highlighted at the Annual AACD conference and in the Soil and Water Matters newsletter.
