Ashley Henderson, PE is a professional engineer with over 30 years of experience in the water sector. Her work spans municipal water and wastewater design, construction, project management, and nonprofit leadership focused on protecting Alabama's waterways. She currently serves as Executive Director of the Alabama Soil and Water Conservation Committee. She served as Director of Conservation Programs, where she led initiatives such as the Alabama Irrigation Initiative, the Alabama Blackbelt Prairie Initiative, and the Alabama Feral Swine Control Program. She is also committed to strengthening Soil and Water Conservation Districts across the state. A Troy native, Ashley earned her Civil and Environmental Engineering degree from Auburn University.



Jerry Sanders is the former President and CEO of Sanco Design, Inc., a soil and erosion control company established by Sanders in 1975. The firm serves as a general contracting firm specializing in creek channel and slope stabilization. Sanders serves as a consultant for the design and implementation of construction activities. With over 40 years of hands-on experience in soil stabilization and erosion control, Sanders has developed and taught training sessions to numerous professional organizations. He has been an active member of the International Erosion Control Association since 1997 and presently serves as the President of the IECA board. Sanders received his B.S.E. degree in Biology and Earth Science from Henderson State University in 1973.



Shelane Bergquist is the Chief of the Construction Permits Section, Water Division at the Alabama Department of Environmental Management (ADEM). She has worked with ADEM and the National Pollutant Discharge Elimination System for 25 years. During this time, Bergquist has worked in construction stormwater and mining programs. She has developed a comprehensive knowledge of permitting, compliance, and enforcement across both programs.



Wesley Donald, PhD is a Research Fellow in the Civil Engineering Department at Auburn University with 15 years of experience in stormwater management. Donald has focused on construction stormwater runoff by investigating the performance of ditch checks, basins, inlet protection, chemical flocculants, and erosion control practices under rainfall simulation. He has also researched catch basin inserts and infiltration swales for post-construction. He serves as committee chair for the IECA's Editorial Review Board and is an active member of IECA's Stormwater committee and its Standards and Practices Committee, and is the state representative for the Southeast chapter of IECA.

Chris Estes is the president of Estes Design, Inc., an environmental design and consulting firm based in Charlotte, North Carolina. The firm specializes in low-impact development design and construction, stormwater quality, and environmental regulatory services. He has conducted and published hydraulic research in peer-reviewed journals and industry publications. Estes developed the first multifamily pervious concrete parking system in North Carolina's Piedmont region. He also assisted the NC Department of Environment and Natural Resources in revising the state BMP Manual section on permeable pavement and continues to work with regulatory commissions to update low-impact development standards.



John Slupecki has over 25 years of experience working in the erosion and sediment control industry, with experience as a project manager, equipment operator, and sales representative for erosion control products with two manufacturers in Alabama, Florida, Georgia, Louisiana, Mississippi, and South Carolina. He has been involved in a multitude of industry organizations and enjoys training in the field.

His primary research focuses on plant taxonomy and systematics, with an emphasis on the biodiversity of Alabama's flora.

Tyler Wayland is the Business Development Manager at Roundstone Native Seed, a family-owned farm that produces and supplies high-quality, regionally adapted, ecotypic native seeds for restoration, habitat enhancement, and conservation efforts across the eastern United States. Roundstone has supported conservation professionals, landowners, and public agencies in restoring healthy, functional plant communities. Wayland plays a central role by connecting projects with the seed resources and expertise needed. He holds a degree in Agribusiness–Ranch Management from Texas A&M University–Kingsville. Before joining Roundstone, he worked with the Texas Native Seeds Program at the Caesar Kleberg Wildlife Research Institute.



Shelley Gordon specializes in environmental compliance, permitting, and Geographic Information Systems. Gordon is a Registered Environmental Manager with TTL's Environmental Services group. Since joining TTL in 2019, she has supported transportation, municipal, and industrial projects across the Southeast. She has degrees from Southern New Hampshire University and the University of Montevallo. Gordon served on the West Alabama Highway Design-Build Project, where she coordinated asbestos inspections, assisted the project's Comprehensive Environmental Protection Plan, and produced GIS mapping. She currently coordinates Qualified Credentialed Inspector (QCI) inspections, manages environmental compliance documentation, and facilitates coordination among project stakeholders.

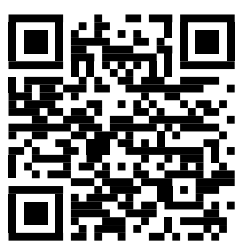

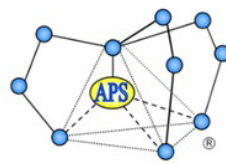

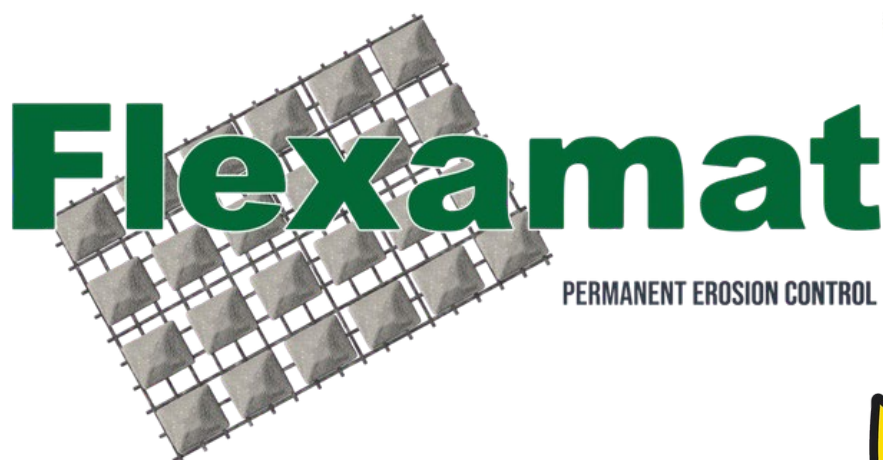
